2) (a) Tender documents consisting of prescribed tender form, this Notice Inviting Tender, details plan, complete specification and the set of condition of contract and other special terms and condition, accompanied with requisite earnest money in sealed cover superscribing the name of work on the envelop and addressed to the undersigned will be received by him upto 15.00 hours on 03/07/2025 and will normally be opened at his office on the same day after wards is presence of the tenders who may be available at that time

(b) Before submitting tender the tenderer must get his, signature attested on the contract from by a witness failing which his tender may be liable to be rejected.

- 3) Tender documents can be had on application and cash payment of requisite amount non-refundable) from the accounts branch of this Corporation in every working day upto 3 p.m. by the intending tenderers personally or by their authorized representatives.
- (a) Tender from other documents can be had on cash payment (non-refundable) at theWest Bengal State Cooperative Ltd., Poura Bhavan Branch of this Corporation upto 3 p.m. from 01/07/2025.
  - (b) Applications accompanied with credentials & required certificates will be received upto 3 p.m. on 30/06/2025.
  - (c) In case any tenderer are unable to produce such certificates along with application and ask for time to do so under Special circumstances he may be allowed upto last date and time of receipt of application and in the even of failure their application will not be entertained.
- i) GST Registration, P. Tax clearance Certificates, PAN Card, Trade Licence and all necessary documents as applicable as per government rules.
  - ii) The bidder must have experience in similar nature of work in any Govt. / Board / Semi Govt. / Corporation / Statutory Authority / Govt. Undertaking organization etc.
  - (a) Intending tenderers should produce credentials of a similar nature of completed work of the minimum value of 40% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice; or,
  - (b) Intending tenderers should produce credentials of 2 (two) similar nature of completed work, each of the minimum value of 30% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice; or.
  - (c) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value at (i) above;
  - iv) In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency. i.e., the tenderer.
- (a) Earnest Money (2%) to be deposited only in the form demand draft / pay order in favour of "Bidhannagar Municipal Corporation". Other than these will not be accepted.
  - (b) No adjustment of any sort of above mentioned earnest money previously deposited for other works will be considered. Tenders without earnest money will be treated as informal.



- 7) (a) The tenderers should quoted the rate in figures and words on basis of percent above, below or at per with the schedule of rates attached with the tender form. The tenders which contains over writing or manipulation are liable to be rejected. All corrections should be attested under the dates initials of the tenderer.
  - (b) the rate quoted in the tender shall remain open for acceptance within 3 (three) months from the date of tender.
- 8) Conditional tender or tenders which do not fulfill any of the above conditions or are incomplete in any respect are liable to Summary rejection.
- 9) Accepting authority does not bind himself to accept the lowest tender and reserve to himself the right to reject any or all of the tenders received without assigning any reason whatsoever and also reserves the right to split up / distribute the work to more than one contractor.
- 10) The tender should, if so desire by Engineer-in-charge submit his analysis to justify the rate quoted by him.
- 11) Payment will be made according to availability of fund.
- 12) If work is not started within time tender will be liable for termination with forteiture of earnest money without assigning any further reason.
